4. B SC NURSING COURSE DETAILS

- This college offer B.Sc. Nursing Degree Programme of 4 year duration as specified by Kerala University of Health Sciences (KUHS), approved by Indian Nursing Council (INC) & Kerala Nurses and Midwives Council (KNMC).
- The maximum period to complete the course successfully shall not exceed twice the actual duration of the course (Eight Years).

5. SEAT DISTRIBUTION

The annual intake for B.Sc. Nursing is 40.

50% of the annual intake allotted to Government merit and 50% allotted to Management seat.

6. ELIGIBILITY FOR ADMISSION

(i) Academic:

Candidates who have passed Higher Secondary Examination of the Board of Higher Secondary Education of Kerala or equivalent examinations recognized by any of the Universities in the State of Kerala with Aggregate of 50 % marks in Physics, Chemistry, Biology and English are eligible for admission.

(i) Relaxation in marks:-

(a) Candidates belonging to SEBC (Socially and Educationally Backward Classes) in the State of Kerala with total annual family income upto Rs.4 lakhs will have relaxation of 5 % marks. The Scheduled Caste and Scheduled Tribe candidates in the state of Kerala need only a pass in the qualifying Examination.

(b) Those candidates claiming relaxation of marks shall produce necessary certificates from the authority concerned. **There will be no reservation of seats for SEBC and or SC/ST candidates under Management quota.**

Eligibility Certificates: Candidates who have passed their qualifying examination from places other than State of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from KUHS, Thrissur. This should be furnished at the time of interview for admission.

Age:

- (i) Applicants should have completed 17 years of age on the 31st December 2024. No relaxation of the minimum age will be allowed.
- (ii) Self-attested copy of relevant page of school record namely SSLC / ICSE / CBSE / certificate showing the date of birth/copy of birth certificate should be produced at the time of admission.

7. HOW TO APPLY

Application for admission to B.Sc.Nursing course can be registered online through a single application. The provision for applying online is available at the website www.pimsnc.com. Submission of more than one application by a candidate will lead to rejection of the applications for the same course submitted subsequent to the first application. Incomplete application, false information will also lead to rejection.

Application Fee:

- (i) The application fee will be ₹.1000/-. The payment can be done via online.
- (ii) Application submission will be completed only after uploading scanned copy of Fees paid acknowledgement.
- (iii) Application fee once remitted will not be refunded in any circumstances.

Availability of Prospectus

Prospectus can be downloaded from www.pimsnc.com. or can be had from the Nursing College office.

Remittance of Application Fee and Submission of Application Form

- There will be three stages for the submission of an application form and all stages are mandatory.
- Candidates shall complete all the stages of submission as per the time schedule which will be notified through the website/media.

Stage1- Entering candidate details online.

Stage2- Online payment of application fee.

Stage3- Submission of completed filled application form.

Remittance of Application Fee and Submission of Application is detail

- (i) Candidate shall visit the official website www.pimsnc.com and click the link “Online Application”.
- (ii) The personal details of the candidate have to be filled in the page thus obtained and saved.
- (iii) Uploading of Photo and signature.
- (iv) Enter the details of qualifying examination.
- (v) Uploading of fee paid acknowledgement & Click ‘SAVE’ Button
- (vi) Click Final Confirmation.

8. PREPARATION OF MERIT LIST & SELECTION

Merit list:

Selection of the candidates is only on the basis of the rank lists prepared and published in the website based on the marks secured by the candidates in the qualifying examination.

- a. Out of total seats, 35% seats will be filled by managements from among the applications received by the college on the basis of merit list prepared based on the marks obtained in the qualifying examination in the core subjects as mentioned in the eligibility criteria.
- b. Out of total seats, 15 % NRI seats shall be filled up from qualified students as per G.O(MS)No.243/2014/HRFWD dated 6.08.2014 of Govt. of Kerala. The documents shall be submitted at the time of admission.

Resolution of tie while ranking:

In the case of a tie in the total marks, the marks in Biology will be counted. If there is still a tie the marks in Chemistry and Physics will be counted. If a tie still exists, the age of the candidate will be taken into account, the elder will be preferred to the younger.

Validity of the merit list:

The published merit list will be valid till the date up to which the merit list shall be kept alive in terms of instruction/direction of competent authority.

Inclusion in the merit list will not entitle the applicant eligible for admission to the course, unless the applicant satisfies the rules regarding the eligibility for admission and other conditions as laid down in the Prospectus.

Furnishing of false information/particulars would result in the forfeiture of the candidature as well as Cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law of the land.

9. ADMISSION

This prospectus contains the rules and regulations for selection and admission to the seats to be filled by management of PIMS College of Nursing for the Academic year 2025-2026.

- Admission process of this college is through college website.
- The selected candidates will be informed about the date and time of admission through the website.
- The students shall pay all fees of the 1st year of the course at the time of admission which will not be refunded at any circumstances.

10. FEE STRUCTURE.

All the candidates admitted shall pay the fees fixed by Government of Kerala / Fee Regulatory Committee and as approved or modified by competent authorities.

Fee may be changed subject to the order from Govt. of Kerala and fee regulatory committee.

All other fees will be as per order no FRC 50/22/B.Sc/P.BSc/M.Sc/NURSING Fee regulatory committee for medical education in Kerala.

Candidates who express their intention not to pursue studies in the Nursing College before the last date fixed for closure of admissions will be eligible for refund of the 1st year tuition fee and other fees except admission fee. They will be eligible to get back their original certificates handed over to the College at the time of admission. In the case of students who leave the College midway, the right of the management for liquidated damages, if any, from such students will be determined by the competent "Civil Court."

11. RECOGNITION OR AFFILIATION

The College affiliated to Kerala University of Health Sciences (KUHS) and recognized by Indian Nursing Council (INC) and Kerala Nurses and Midwifery Council (KNMC).

12. SYSTEM OF EXAMINATION

Examinations are conducted as prescribed by the Kerala University of Health Sciences.

Each candidate should put in a minimum of 80% of attendance of the prescribed hours in each subject in theory and practical separately wherever applicable in each academic year to appear for the university examination. However the candidate shall complete 100% attendance in practical before the award of degree.

13. COLLEGE FACILITIES

The college has adequate infrastructure facilities as per the INC norms. We have well equipped and furnished labs to augment the nursing skills development of the students.

The college has well designed Principal office, Vice Principal office, HOD Rooms, Faculty rooms, and Office section.

The college library is spacious and well-furnished with a collection of around 3852 books in different subject of nursing and latest edition books are added every year. There is an internet facility available for the students and faculty separately.

The store caters to the immediate stationary needs of the students at very nominal charge and is open on all working days. Cafeteria is available within the campus which provides easy access for students seeking to refresh themselves with snacks during short breaks

14. SPECIAL INSTRUCTIONS

1. **Ragging:** Ragging in any form is strictly prohibited in college. College is committed to abolish ragging in the campus. Hence any student who indulges in any form of ragging will be subjected to penal action as per provisions of law. Also, the student will be expelled from the college as detailed in the law concerned and as per Honorable Supreme Court of India directions in this regard.
2. **Use of Mobile Phone:** Use of Mobile Phone by students are restricted during academic hours. Any violation of this prohibition will lead to stringent disciplinary action by the college authorities.
3. **Substance Abuse Policy:** Substance Abuse may interfere with student's educational objectives as well as academic environment within the campus. Therefore we have a stringent policy governing the use of tobacco, alcohol and other abusive substances. The purchase, possession, use, conception, sale, distribution, or storage of any alcoholic beverages, controlled substance or illegal drug is prohibited in the campus & hostel, training sites, student events, conferences and other activities.. Under suspicious circumstances the students may be tested at random for substance abuse at any point of time during their stay on campus.

4. **Uniform :** There will be designated uniform for students and it's compulsory. Students will be permitted to attend classes or clinical postings only in designated uniform. They should come to the College properly and neatly dressed in accordance with the college dress code and have to wear prescribed uniform with ID card while they are in college campus and additionally overcoat is compulsory in the clinics.

5. **Parent Teacher Association :** There is an active PTA in this institution and all Non-academic action will be implemented with the approval of PTA. All the PTA members and Executive Committee members should attend the PTA General Body and Executive Committee meetings respectively without failure.

6. **Security :** The institution is under CCTV surveillance. All areas of the institution are covered, except toilets and designated private zones. CCTV Policy is implemented. Any student going out of campus should get permission from the College authorities and the gate pass should be shown to security at the main gate.

7. The said policies are applicable to the existing students as well as to the newly admitted students. Any other items not specifically covered in this prospectus will be decided by the Controller of admission.
